



THE DEFENCE OF DISSERTATION REQUEST

The Request must be filed in writing with the Study Department, but it must be addressed to the Dean of the Faculty. **Requirements** specified in the *Dean's of the FAT USB ordinance dealing with the studies in doctoral study programmes* (hereinafter only the Dean's Ordinance).

Attach to the Request a filled **Annex to the Defence of Dissertation Request** signed by the student, the supervisor, and the chairman of the Subject Advisory Board (SAD).

The structure and composition of the committee must follow the Dean's ordinance. Indicate in the Annex to the Request the proposition of the opponents to the dissertation and state whether they are members of the committee. The chairman names the opponents with the approval of the members of the committee.

Please study carefully all terms and requirements and file the request form with a sufficient time reserve (**at least 8 weeks**) before the planned term of the defence respecting all provisions of the Dean's Ordinance to avoid the refusal of your request and the subsequent postponement of your defence.
